## Trakm8 Grey Fleet Survey Competition - Terms and Conditions

## 1. HOW TO ENTER

- **1.1** The competition will run once the Grey Fleet survey is launched from **9.00am** on **07/04/2021** (the "Opening Date") until **5.00pm** on **07/05/2021** (the "Closing Date").

Once you visit the link, it will take you to a landing page where you will need to complete all 18 questions; this will include questions 17 & 18 which will ask for Full Name & Work Email address. Your name and email address details are for prize draw purposes only. All details in the survey will remain anonymous.
- **1.3** All competition entries must be received by the Promoter no later than **5.00pm** on the Closing Date. All competition entries received after that time are automatically disqualified.
- **1.4** The winning entry will be selected at random using a random name selector tool from all entries received between the dates and times outlined above in accordance with these terms and conditions.
- **1.5** The prize draw is free to enter and no purchase is necessary.
- **1.6** By submitting an entry, you are agreeing to be bound by these terms and conditions.
- **1.7** The Promoter will not accept responsibility for competition entries that are lost or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind. Proof of transmission is not accepted as proof of receipt of entry to the competition.
